1. On May 2, 2011, the Public Service Commission issued an *Order Setting Procedural Schedule, Notice of Hearing, and Order Directing Notice*. This *Order* set forth May 19, 2011 as the date to file a motion to modify the procedural schedule.

2. On May 12, 2011, after the “on-the-record” portion of the prehearing conference Veolia Energy Veolia Energy Kansas City, Inc. (Veolia), Staff and intervenor applicant, Southern Union Company d/b/a Missouri Gas Energy (MGE) discussed the Commission ordered procedural schedule.
