ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

On April 16, 2018, KCP&L Greater Missouri Operations Company (GMO) filed the pending tariff sheet setting forth the quarterly cost adjustment (QCA) for the first quarter of calendar year 2018. Staff filed its recommendation in favor of the tariff.

Staff states that it has reviewed the tariff and the mathematical calculations GMO provided and is of the opinion that GMO has calculated the QCA for the first quarter of 2018 in accordance with the appropriate tariff sheets. Staff recommends that the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. No other responses to the tariff were filed.

The Commission has reviewed GMO's tariff sheet and Staff's verified recommendation. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission's previous orders and GMO's current tariff provisions. The Commission approves the tariff sheet as ordered below.
