(Vicinity) filed a Notice Regarding August 1 PACC Filing (Notice), stating that it would not be making the August 1, 2021 PACC filing that was anticipated in the stipulation approved by the Commission on March 24 in its Order Approving Stipulation and Rejecting Production Adjustment Cost Clause (PACC) Tariff. On August 24, the Commission issued its Order Directing Filing requiring the Commission's Staff (Staff) no later than September 11 to file a report and recommendation regarding Vicinity's notice or a pleading suggesting a date by which Staff would do so. On September 10, Staff filed its Proposed Filing Date, praying that the Commission would grant Staff until October 20 to file its report and recommendation. The Commission will grant Staff's request.

THE COMMISSION ORDERS THAT:

1. No later than October 20, 2021, the Staff shall file a report and recommendation on Vicinity's Notice Regarding August 1 Production Adjustment Cost Clause Filing.
