- 1. On November 20, 2018, the Commission issued its *Order* which directed the parties to file jointly or separately a status report no later than January 23, 2019. This pleading is being filed in response to the *Order*.
- 2. As explained at the procedural conference held on October 25, 2018, GMO and its customers have been actively engaged in discussions concerning a possible resolution of this matter. (Tr. 87-89) These discussions have been constructive, and are continuing at this time.
