**KCP&L GREATER MISSOURI OPERATIONS COMPANY'S  
RESPONSE TO ORDER DIRECTING FILING**

Pursuant to 4 CSR 240-2.080, KCP&L Greater Missouri Operations Company ("KCP&L-GMO" or "Company") hereby respectfully submits to the Missouri Public Service Commission ("Commission") its Response To Order Directing Filing. In support of its response, KCP&L-GMO states as follows:

1. On January 22, 2010, the Commission Staff ("Staff") filed its Recommendation to approve GMO's true-up filing in this case. In its Recommendation, the Staff recommends the Commission approve GMO's true-up filing for its second recovery period (September 1, 2008 through August 31, 2009), based on GMO under-collecting \$988,989 from its customers in the former Aquila MPS territory and under-collecting \$175,393 from its customers in the former Aquila L&P territory during that second recovery period. The under-collected amounts confirmed in this case, Case No. EO-2008-0415 will be reflected in GMO's current FAC filing to adjust its Cost Adjustment Factors ("CAF") in Case No. EO-2010-0191 for the fifth accumulation period of its FAC.

2. On January 25, 2010, the Commission issued its Order Directing Responses in which it ordered that any responses to the Staff's Recommendation to Approve True-Up Filing shall be filed no later than February 1, 2010.

3. For its Response To Order Directing Responses, KCP&L-GMO states that it agrees with the Staff Recommendation To Approve True-Up Filing, and wishes to express its sincere appreciation to the Staff personnel, particularly Matt Barnes and Mack McDuffey, who have worked so diligently to review and process this case.

**WHEREFORE**, for the foregoing reasons, KCP&L-GMO respectfully requests that the Commission accept Staff Recommendation To Approve True-Up Filing.
