Pursuant to 4 CSR 240-2.080, KCP&L Greater Missouri Operations Company ("KCP&L-GMO" or "Company") hereby respectfully submits to the Missouri Public Service Commission ("Commission") its Response To Order Establishing Deadline For Responses. In support of its response, KCP&L-GMO states as follows:

1. On January 22, 2010, the Commission Staff ("Staff") filed its Staff Recommendation To Approve Tariff Sheet in this case. In its Recommendation, the Staff recommends that the Commission issue an interim rate adjustment Order approving GMO's Tariff Sheet, P.S.C. MO. No. 1, 1st Revised Sheet 127.5 Canceling Original Sheet No. 127.5, as filed on December 23, 2009, to become effective on March 1, 2010, subject to true-up and prudence review.

2. On January 25, 2010, the Commission issued its Order Establishing Deadline For Responses in which it ordered that any responses to the Staff's Recommendation shall be filed no later than 4:00 PM on Monday, February 1, 2010.
