On May 18, 2022, the Commission issued its *Order Establishing Procedural Schedule, Establishing Test Year, and Other Procedural Requirements*. The order set a Discovery Conference for June 22, 2022. The order also requires that any party that has a discovery concern file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference.

Staff filed a *Statement of Discovery Concern or Dispute* on June 17, 2022, indicating that it was having discovery issues necessitating a discovery conference. On June 21, 2022, Staff informed the Regulatory Judge that the discovery conference was no longer necessary.

There are currently no discovery disputes requiring a discovery conference and the scheduled discovery conference is less than three business days away. Thus, the discovery conference is canceled.

- 1. The June 22, 2022, discovery conference is canceled.
