

forth in the Agreement, the Commission's Order is set to take effect on an expedited basis, with an effective date of December 10, 2022.

4. The purpose of this Motion for Expedited Treatment (this "Motion") is to enable the Revised Tariff Sheets, filed contemporaneously with this Motion, to become effective on December 26, 2022 to effectuate the intent of the parties.

5. Spire Missouri submits that harm will be avoided by expedited approval of the Revised Tariff Sheets since it will permit the Company to begin collecting updated rates that are just and reasonable for both the Company and its customers. There will be no negative impact on customers or the general public if the Commission grants such relief, supported by the fact that no party opposed the Company's request to have rates become effective on December 26, 2022.

6. Spire Missouri also notes that no additional burden will be imposed on Staff by the granting of this Motion, as the Company already provided its proposed Revised Tariff Sheets, reflecting the provisions of the Agreement, to Staff on November 14, 2022. The major tariff changes include revisions to (1) the Transportation tariffs, which were filed with the Agreement after extensive negotiations among the parties, (2) the Payment Partner Program tariff, which mirror terms of the Agreement, and (3) the rate tariffs, which reflect the stipulated revenue requirement. Because the tariff revisions in this case are relatively minor, and were largely included with the Stipulation, Spire Missouri believes Staff and the intervenors will have ample time to review the Revised Tariff Sheets for an effective date of December 26, 2022.

7. This pleading was filed as soon as it could have been following the Company's preparation and filing of the Revised Tariff Sheets implementing the terms of the Order issued by the Commission on November 30, 2022.

WHEREFORE, for all the foregoing reasons, Spire Missouri respectfully requests that the Commission consider and grant this Motion for Expedited Treatment to effectuate the intent of the parties by approving the Revised Tariff Sheets to become effective on December 26, 2022.
