#### ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: November 7, 2022 Effective Date: November 7, 2022 On November 4, 2022, The Empire District Gas Company d/b/a Liberty filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment Factor. Liberty is also seeking a carrying cost for extended recovery relating to extraordinary costs stemming from Winter Storm Uri at a rate of 8.0 percent. The tariff sheets bear an effective date of December 4, 2022.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

1. No later than November 14, 2022, Staff shall file a recommendation with regard to Tariff File No. YG-2023-0088.

2. Any other entity wanting to comment on the tariff sheets or respond to Staff's recommendation shall do so no later than November 16, 2022.
