**NOTICE THAT APPROVED RATE INCREASE WILL NOT EXCEED 7%
THRESHOLD IN SECTION 393.275, RSMo.**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri"), by and through counsel, provides this *Notice that the Approved Rate Increase Will Not Exceed the 7% Threshold in Section 393.275, RSMo.*, and states as follows:

1. On December 3, 2021, the parties to the above-captioned matter filed two stipulations and agreements that together resolved all pending issues. In the first stipulation and agreement, the parties agreed for Ameren Missouri to be authorized to increase its annual gas revenues by \$5.0 million, exclusive of any applicable license, occupation, franchise, gross receipts taxes, or similar fees or taxes.¹

2. By order effective January 4, 2022, the Commission approved the two stipulations and agreements.

3. Section 393.275, RSMo. (2016), requires the Commission to notify the governing body of each city and county that imposes a business license tax or similar tax of approved utility rate increases that exceed 7%.

4. Via order issued January 19, 2022, the Commission directed Ameren Missouri to "file a pleading indicating whether the approved \$5.0 million rate increase will exceed the seven

percent threshold established in Section 393.275, RSMo 2016."²

5. Ameren Missouri hereby responds to the Commission's Order and confirms that the approved \$5.0 million annual revenue increase equates to a rate increase that will **not** exceed the 7.0% threshold established in Section 393.275, RSMo.

6. Accordingly, no information required by Commission Rule 20 CSR 4240-10.060 is necessary to be provided to the Commission.

WHEREFORE, Ameren Missouri respectfully requests that the Commission accept this Notice, and for any other relief the Commission deems appropriate.
