Enclosed for filing with the Missouri Public Service Commission ("Commission") is revised Sheet No. 66 for incorporation into Granite Telecommunications, LLC's ("Granite") Missouri switched access tariff, Missouri P.S.C. Tariff No. 2.

With this filing, Granite complies with the Federal Communications Commission's ("FCC") *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-161 (the "ICC USF Transitional Order"). Specifically, Granite reduces its intrastate switched exchange access rate by 50 percent of the differential between its intrastate rate and interstate rate in accordance with the ICC USF Transformational Order effective July 3, 2012.<sup>1</sup>

Also enclosed pursuant to the Commission's March 4, 2011 Order in File No. TT-2012-0317 ("Order") is Granite's confidential demand data spreadsheet in the format provided by the Commission and marked proprietary and confidential. An oath attesting to the accuracy of these data is also enclosed. Per the Commission's Order, an August 11, 2012 effective date is requested, 60 days from the issue date.
