# ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: July 3, 2023 Effective Date: July 3, 2023

On June 30, 2023, Spire Missouri Inc. (Spire Missouri or "the Company") filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets assigned Tracking Number JG-2023-0230. Spire Missouri projected that the changes to the WNAR tariff sheets will increase the monthly bill of the average Spire East residential customer by \$0.95 cents per month. For the average Spire West residential customer, the increase is \$0.69 cents per month. The tariff sheets bear a September 1, 2023, effective date.

The Staff of Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

- No later than August 2, 2023, Staff shall file a recommendation regarding Tracking No. JG-2023-0230.
