

On September 5, 2008, Aquila, Inc., d/b/a KCP&L Greater Missouri Operations Company, filed tariff revisions intended to implement a general rate increase for steam heating service provided in its Missouri service area. The proposed tariff sheets bear a requested effective date of August 5, 2009. On September 12, 2008, the Commission issued an order giving notice of the filing and setting procedural dates, including an intervention deadline.

Ag Processing, Inc., a Cooperative, filed a timely application to intervene on September 16, 2008. AGP, a manufacturer and processor of soybean meal and other grain products, operates a major processing facility in St. Joseph, Missouri, and is an industrial steam customer of Aquila. AGP asserts that because of the structure of the rate schedules under which Aquila sells industrial steam to AGP, and because of its size and consistency of steam usage, AGP is in the position of representing its own interest, which is direct, immediate, different from that of the general public, and which cannot adequately be represented by any other party. For purposes of 4 CSR 240-2.075(2), AGP states that it opposes the relief sought by Aquila in this proceeding.

No response has been filed to AGP's application and the time for doing so has now passed. The Commission has considered AGP's application to intervene and finds it to be in compliance with 4 CSR 240-2.075. AGP shall therefore be granted intervention.

THE COMMISSION ORDERS THAT:

1. The Application to Intervene filed by Ag Processing, Inc., a Cooperative, is

granted.

2. This order shall become effective upon issuance.
