**ORDER APPROVING TARIFF SHEETS FILED IN COMPLIANCE  
WITH COMMISSION ORDER**

Issue Date: June 24, 2009

Effective Date: July 1, 2009

On June 10, 2009, the Commission issued its order approving the Unanimous Stipulation and Agreement of the parties in this matter. The Commission rejected the original tariff filed by KCP&L Greater Missouri Operations Company (GMO) and authorized GMO to file new tariff sheets in compliance with the agreement. The Commission noted in its order that one of the provisions of the agreement is that rates would be implemented on and after July 1, 2009. Furthermore, because exemplar tariffs have been on file at the Commission since May 13, 2009, and all parties agree to those tariffs becoming effective on July 1, 2009, the Commission found that good cause exists to approve tariffs in compliance with the order without the need for those tariffs having been filed for an additional 30 days.

GMO filed revised tariff sheets, Tariff No. YH-2009-0862, on June 17, 2009. The tariff sheets bear an effective date of July 1, 2009. The Commission set expedited deadlines of June 22, 2009, for the Commission Staff's recommendation, and June 23,

2009, for any other parties to file responses to the proposed tariff sheets or to Staff's recommendation.

On June 22, 2009, Staff filed its recommendation concerning GMO's tariff sheets. Staff has reviewed GMO's tariff filing and determined that it complies with the Commission's order and the Unanimous Stipulation and Agreement. Staff recommends that the Commission approve the tariff sheets to become effective on and after July 1, 2009.

No responses to GMO's tariff filing or to Staff's recommendation were filed.

The Commission has reviewed GMO's tariff sheets and the Staff's verified recommendation. The Commission concludes that the submitted compliance tariff is consistent with the Unanimous Stipulation and Agreement and with the Commission's order approving that agreement, and shall therefore be approved. Because one provision of the agreement is that rates would be implemented by July 1, 2009, the Commission previously determined that good cause exists pursuant to Section 393.140(11), RSMo 2000, to approve the tariffs on less than 30 days notice. The Commission shall approve GMO's revised tariff to become effective July 1, 2009.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets filed by KCP&L Greater Missouri Operations Company on June 17, 2009, in Tariff File No. YH-2009-0862, are approved to become effective on July 1, 2009. The tariff sheets approved are:
