**MOTION TO MODIFY PROCEDURAL SCHEDULE BY EXTENDING THE FILING  
DATE FOR SURREBUTTAL TESTIMONY TO JUNE 27, 2014**

**COMES NOW** the Staff of the Missouri Public Service Commission and, moves the Commission extend the date for the filing of surrebuttal testimony to June 27, 2014. In support thereof, Staff states the following:

1. In its January 16, 2014, *Order Setting Procedural Schedule, Establishing Test Year And Guidelines For Discovery* (“Order”), the Commission set June 18, 2014 for all parties to file surrebuttal testimony, which is 14 days after the filing of rebuttal testimony.

2. The parties had originally proposed a surrebuttal filing date of July 3, 2014 and evidentiary hearing dates of July 15-18. Due to external scheduling issues, the Commission’s Order set the hearing dates to July 8-11, 2014, and advanced surrebuttal filing to June 18<sup>th</sup>.

3. With respect to the ordered hearing dates of July 8-11, the Staff believes that an extension of the surrebuttal filing date to June 27<sup>th</sup> would allow the parties additional time for discussing and narrowing the issues and for preparation of surrebuttal testimony. Accordingly, the Staff respectfully requests the surrebuttal filing date be extended an additional nine (9) days to June 27, 2014.

4. Staff counsel has discussed this matter with counsel for the parties and is authorized to represent that no party opposes this motion.

**WHEREFORE**, for the above stated reasons, the Staff prays the Commission will accept its motion and reset the filing date for surrebuttal testimony to June 27, 2014.
