**INITIAL CUSTOMER NOTICE**

Dear Customer:

On December 16, 2022, Vicinity Energy Kansas City, Inc. (Company) filed a rate case requesting no increase in steam heat revenues with the Missouri Public Service Commission (Commission). The reason for the case is tied to our current tariff and Production Adjustment Cost Clause (PACC), which requires the filing of a rate case at no less than four-year intervals. By its request, the Company is not otherwise seeking changes to its customer rates. However, the Staff of the Public Service Commission and the Office of Public Counsel may conduct their own audits and determine if changes in rates are necessary.

To provide comments regarding the Company's rate case, or comments regarding service-related problems, you may contact the Commission Staff and/or the Office of the Public Counsel (Public Counsel) ***within 30 days of the date of this notice***. Your comments should include a reference to case number HR-2023-0198. The Commission Staff and the Public Counsel will review all customer comments submitted in response to this notice. All comments will be filed in the official case file for review by the Commissioners.
