## ORDER DIRECTING FILING AND SETTING CONFERENCE

The Missouri Public Service Commission is setting the date for the filing of responses to Staff's recommendation and a conference.<sup>1</sup>

Staff filed its recommendation on November 8<sup>2</sup> at 3:43 p.m. On November 9 at 1:09 a.m., AG Processing, Inc. ("AG Processing"), filed a motion.<sup>3</sup> KCP&L Greater Missouri Operations Company ("GMO") filed a response on November 10.<sup>4</sup>

AG Processing claims that it had no notice of the application. GMO alleges that it served notice of this action on AG Processing. AG Processing seeks to file a response to the recommendation. GMO asks for a conference to discuss the issues. The Commission will grant that request.

### THE COMMISSION ORDERS THAT:

1. AG Processing, Inc., shall be a party to this action.
