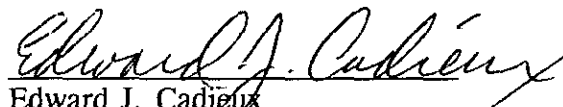

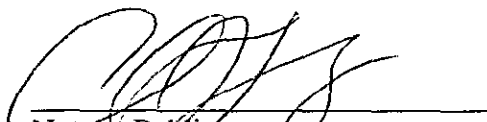

1 Direct Testimony of Edward J. Cadieux
2 on Behalf of
3 MCIMetro Access Transmission Services, Inc.

1 **Introduction and Background**

2 **Q. State your name.**

3 **A. Edward J. Cadieux.**

4 **Q. Did you submit direct testimony in this case on behalf of MCIMetro Access**
5 **Transmission Services, Inc?**

6 **A. Yes, I did.**

7 **Q. In your direct testimony you indicated you would soon be changing employers. Has**
8 **that change now taken place?**

9 **A. Yes.**

10 **Evaluation of Asset Purchase Transaction**

11 **Q. Have you reviewed the rebuttal evidence submitted by the City of St. Louis in this**
12 **case?**

13 **A. Yes, I have.**

14 **Q. Does that rebuttal evidence contradict your direct testimony?**

15 **A. No, it does not.**

16 **Q. Specifically, does the City's rebuttal evidence contradict or support your testimony**
17 **that a determination was made that it was not necessary to obtain the Commission's**
18 **approval of the 1990 asset purchase transaction?**

1 A. The City's evidence supports my testimony. The City has submitted the deposition
2 testimony of Kathryn Brown, who testifies at pages 8 and 11-12 that she was an attorney
3 employed by Western Union and was directly involved in the transaction. She also
4 testifies at pages 70-72 that Western Union made the same determination as MCI that the
5 transaction did not require Commission approval.

6 Q. **At page 75 of her deposition, Ms. Brown was asked whether she believed the assets**
7 **were necessary and useful to Western Union in fulfilling its contractual obligations**
8 **to its Missouri customers, and she responds affirmatively. Do you agree?**

9 A. Of course.

10 Q. **But if the assets were necessary and useful to Western Union in fulfilling its**
11 **contractual obligations to its customers, why wasn't it necessary to obtain**
12 **Commission approval of the transaction?**

13 A. Because Section 392.300.1 R.S.Mo. only requires Commission approval of the transfer
14 of assets necessary and useful to a telecommunications company in performing its duties
15 to the public. This corresponds to the definition of telecommunications companies and
16 telecommunications services, which in turn is the provision of services for hire to the
17 public under Section 386.020. Again, the ATS division of Western Union Corporation
18 was merely leasing intrastate wires and conduit or pole space to utilities and railroads.
19 It was not providing regulated public service and did not need approval to sell its assets,
20 just as it did not need approval to lease them to its customers.

21 Q. **Does the City's rebuttal evidence contradict or support the determination that it was**
22 **not necessary to obtain Commission approval of the transaction?**

1 A. The City's evidence supports the determination. The deposition testimony of Kathryn
2 Brown and MCIMetro employee Steve Shannon just goes into further detail regarding the
3 nature of the assets in Missouri that were sold and the way Western Union was using
4 those assets at the time of the sale, as I described at pages 4-5 of my direct testimony.

5 At pages 12 and 27 and Exhibits A and B of his deposition testimony Mr. Shannon
6 identifies all Missouri intrastate customer contracts as of the date of the sale, as follows:

15 True and accurate copies of Mr. Shannon's Exhibits A and B are attached hereto as
16 Schedules 3 and 4.

17 Mr. Shannon also explains in his deposition testimony, at pages 16 and 49-51, that these
18 customers were simply provided fiber optic cable, in the case of SM or single mode
19 fibers, or copper wires, in the case of PR or copper pairs, and nothing more. This
20 provision of wires is exactly what I described at page 4 of my direct testimony. He uses

1 the word "capability" in the same sense that I used the word "capacity", as he explains
2 at page 81 of his deposition.

3 Mr. Shannon also explained at pages 82-91 of his deposition that Western Union and
4 other right-of-way users like utilities such as Southwestern Bell Telephone Company, and
5 railroads such as Burlington Northern, shared facilities such as conduit space, exactly as
6 I described at page 4 of my direct testimony. Such sharing practices would include any
7 free use made of conduit and poles by the City under its contract with Western Union,
8 now assigned to MCIMetro, as described in Mr. Shannon's deposition at pages 117-123.
9 Such practices are unregulated according to Section 392.120 R.S.Mo.

10 Kathryn Brown also confirms my description of Western Union's use of its Missouri
11 assets in her deposition at pages 20-25 and 59-60.

12 **Q. At page 98 of his deposition testimony Mr. Shannon and counsel for the City discuss**
13 **LDDS as a customer of Western Union and imply that it was a Missouri customer.**
14 **Was that accurate?**

15 **A.** No, by the time of trial in the Circuit Court case it had been determined that the
16 reference to LDDS was erroneous, as reflected in the deposition of MCIMetro employee
17 Ellie Chiampa at page 89, a true and accurate copy of which is attached hereto as
18 Schedule 5.

19 **Q. Did your review of Mr. Shannon's deposition Exhibit B alert you to a mistake in**
20 **your direct testimony?**

1 A. Yes, when I identified the 1990 Missouri revenues derived from the ATS assets which
2 were sold to MCIMetro, I worked from the numbers identified in the Circuit Court
3 litigation with the City of St. Louis, which did not include revenues in Kansas City. I
4 wish to correct my testimony in this regard to reflect that the total Missouri annual
5 revenues from these assets at the time of sale were approximately \$130,000.00, as
6 reflected in the deposition testimony (including Exhibits A and B) of Mr. Shannon.

7 **Q. Does this correction affect any other part of your testimony?**

8 A. No.

9 **Q. And after reviewing the City's rebuttal evidence, is it still your opinion to a**
10 **reasonable degree of legal certainty that it was not necessary to obtain Commission**
11 **approval of the asset purchase transaction?**

12 A. Yes.

13 **Q. In your direct testimony you stated that the asset purchase transaction would not**
14 **effect tax revenues of Missouri political subdivisions. Mr. Stone testifies on this**
15 **issue as well. Have you reviewed his testimony?**

16 A. Yes.

17 **Q. Doesn't Mr. Stone contradict your testimony regarding impact on tax revenues?**

18 A. While at first blush it may appear that way, upon closer examination he does not. I
19 agree with Mr. Stone that companies that had no previous contract with the City have
20 agreed to pay license fees under Chapter 23.64 of the City Code, which was adopted in
21 1991. I also agree with him that even though Southwestern Bell provides the same
22 services as the companies that are paying the license fees (as established in the deposition

1 testimony of Steve Shannon submitted by the City at page 152), it does not pay such fees
2 but rather pays a gross receipts tax on its local exchange service.

3 What Mr. Stone leaves out is that MCIMetro now also provides the same services as
4 these other companies, but has not agreed to pay license fees under Chapter 23.64
5 because it is the assignee of Western Union's contract with the City which has allowed
6 right-of-way use in exchange for conduit and pole access since the late 1800s. He also
7 does not mention that the City has tried at least three times to unilaterally amend this
8 contract to impose a fee, and that the United States Supreme Court held it could not do
9 so at the turn of the century, the Missouri Court of Appeals held it could not do so in
10 1988, and the Circuit Court of the City of St. Louis held it could not do so in 1995. The
11 City's inability to unilaterally modify a contract does not equate to granting MCIMetro
12 an "exemption" from the fees which other companies agree to pay under Chapter 23.64 -
13 it is simply the contractual right of MCIMetro under the pre-existing agreement properly
14 assigned to it by Western Union. Moreover, as Mr. Stone makes clear in his testimony,
15 these license fees are paid under agreements, they are not taxes.

16 A debate over the question of whether MCIMetro now has a competitive advantage
17 because it acquired the Western Union contract has no relevance to this proceeding.
18 Western Union had the same rights before the transaction. Moreover, MCIMetro did not
19 gain any advantage under Chapter 23.64 at the time of the transaction in 1990, because
20 Chapter 23.64 did not yet exist. The City may or may not have imposed a disadvantage

1 on others when it adopted Chapter 23.64 a year later. At that point, Southwestern Bell
2 would have gained the same benefit as MCIMetro, if any, yet at least five new
3 competitors have entered the market, not including MCIMetro, according to Mr. Stone's
4 testimony. If the City nonetheless truly believes its new ordinance stifles competition,
5 then it should repeal that ordinance under the Telecommunications Act of 1996.

6 As for the City's plans to impose a gross receipts tax on local service providers, I am
7 not aware of any authority which would exempt MCIMetro from such a tax. All of the
8 court rulings that I am familiar with concerning the disputes between the City and
9 Western Union and subsequently MCIMetro have involved attempts to unilaterally
10 modify contractual fees, not to impose a tax. As far as I know, the City retains all of
11 its tax powers.

12 While I agree the City must comply with Section 253 of the Telecommunications Act of
13 1996, and while I agree that MCIMetro's contract rights cannot be impaired by that
14 legislation, such matters have nothing to do with this proceeding. Whether the
15 Telecommunications Act now limits the City in 1996 to making contracts identical to
16 those entered in the 1800s, or whether the age of a contract constitutes a different set of
17 circumstances justifying different contracts is a question yet to be resolved, along with
18 the legality of the City's disparate treatment of Southwestern Bell. And the FCC has
19 jurisdiction over such questions under Section 253 of the Telecommunications Act.

1 Under Section 392.300.1 R.S.Mo., only a transaction's impact on tax revenues is
2 relevant. To my knowledge, MCIMetro pays all taxes imposed on it, just as it appears
3 Western Union did before the transaction. The City can impose new taxes as well. Its
4 tax revenues and powers have not been impacted by the asset purchase transaction. Even
5 the Telecommunications Act of 1996 leaves all existing taxes intact except those
6 regarding direct broadcast satellite television services, under Sections 601 and 602.

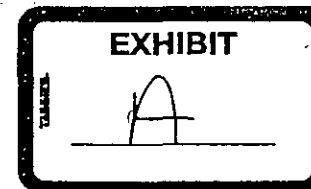
7 In short, Mr. Stone's "concerns" only involve contractual revenues, which are not
8 relevant under Section 392.300.1 R.S.Mo. He does not contradict my statement
9 regarding tax revenues.

10 Conclusion

11 **Q. Does any of the City's rebuttal testimony provide grounds for the Commission to**
12 **deny MCIMetro the relief it seeks in this case?**

13 **A. No. The relevant portions of the rebuttal testimony offered by the City support**
14 **MCIMetro's application in this case.**

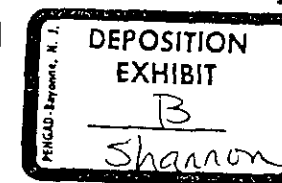
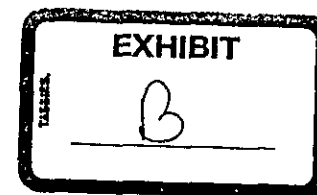
