On February 16, 2022, Summit Natural Gas of Missouri, Inc. (SNGMO) submitted an application requesting financing authorization for its parent company, Summit LDC Holdings, LLC to issue additional indebtedness secured by a pledge of SNGMO's capital stock. SNGMO supports its request by noting that its purpose is to take advantage of historically low interest rates, increase capacity for capital expenditures, fund a portion of incurred winter storm costs, and fund working capital needs.

SNGMO also requests waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017, and expedited treatment so that the Commission issues a final order in this matter effective no later than May 8, 2022.

The Commission will direct its Staff to file a recommendation regarding SNGMO's application.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding SNGMO's application requesting financing authorization no later than March 9, 2022, or a status report indicating when it will be able to file a recommendation.

2. This order is effective when issued.
