### ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: August 9, 2018 Effective Date: September 1, 2018

On July 16, 2018, KCP&L Greater Missouri Operations Company (GMO) filed the pending tariff sheet setting forth the quarterly cost adjustment (QCA) for the second quarter of calendar year 2018. Staff filed its recommendation in favor of the tariff.

Staff states that it has reviewed the tariff and the mathematical calculations GMO provided and is of the opinion that GMO has calculated the QCA for the second quarter of 2018 in accordance with the appropriate tariff sheets. Staff recommends the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. No other responses to the tariff were filed.
