ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES

On October 15, 2021, Evergy Missouri West, Inc., d/b/a Evergy Missouri West ("Evergy West") filed steam tariff sheets (Tracking No. YH-2022-0075) to change the calculation of Evergy West's Quarterly Cost Adjustment ("QCA") rider for steam service. The tariff sheets have an effective date of December 1, 2021. The tariff sheet proposed QCA rate is \$0.3389 as compared to the current effective credit rate of \$0.02369. Evergy West states the increase in the QCA rate is driven by higher natural gas prices during the third quarter of 2021 as compared to the same time period in 2020.

The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on Evergy West's tariff sheets. A deadline will be set for any other party to file a response to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Evergy's West's tariff sheets no later than 9:00 a.m. on November 15, 2021.
2. Any party wishing to comment on the tariff sheets shall do so no later than 9:00 a.m. on November 15, 2021.

3. This order shall be effective when issued.
