## ORDER CANCELLING PROCEDURAL SCHEDULE

On April 13, 2022, the Commission ordered a procedural schedule requiring Staff to file its rebuttal testimony or recommendation regarding Vicinity Energy, Kansas City, Inc's. (Vicinity) proposed substitute tariff sheets (Tracking No. YH-2022-0218), and setting a hearing date for June 6, 2022. On May 12, 2022, Staff filed a motion to amend the procedural schedule explaining that the parties are working together to finalize the proposed tariff sheets and requesting the Commission to set the established schedule back two weeks so the parties may resolve all issues, and for Staff to file its recommendation by May 27, 2022. A proposed procedural schedule was included with Staff's motion.

The Commission will cancel the present procedural schedule and require Staff to file its rebuttal testimony regarding the proposed substitute tariff sheets no later than May 27, 2022. If the matter is not resolved at that time the Commission will take further action to establish an alternate procedural schedule.

### THE COMMISSION ORDERS THAT:

1. The current procedural schedule in this matter is cancelled.
2. Staff shall file its rebuttal testimony or its recommendation regarding Vicinity's proposed substitute tariff sheets no later than May 27, 2022.

3. This order shall be effective when issued.
