ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On January 17, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed steam tariff sheets (Tracking No. YH-2023-0133) to change the calculation of Evergy West's Quarterly Cost Adjustment (QCA) rider for steam service. The tariff sheets have a proposed effective date of March 1, 2023. The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation regarding Evergy West's tariff sheets. A deadline will be set for any other party to file a response to the tariff sheets or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Evergy West's tariff sheets no later than February 16, 2023.
2. Any party wishing to comment on the tariff sheets or Staff's recommendation shall do so no later than February 17, 2023.
3. This order shall be effective when issued.
