> Re: Notice of Election and Withdrawal of Southwestern Bell Telephone Company d/b/a/ AT&T Missouri Tariffs Pursuant to §392.461, RSMo, enacted by House Bill No. 338

Dear Mr. Reed:

As a result of recent changes in state law governing the regulation of telecommunications services in Missouri, §392.461, RSMo was enacted on August 28, 2011 by House Bill No. 338. Section 392.461 allows telecommunications companies, upon notice to the Missouri Public Service Commission ("Commission"), to elect to be exempt from the requirement that they offer retail services to residential or business end users only through tariff, and to withdraw such tariffs. However, the law requires electing companies to publish generally available retail prices on a website.

Southwestern Bell Telephone Company, d/b/a/ AT&T Missouri ("the Company") hereby gives the Commission notice of its election to be exempt from tariff filing requirements relating to, and of its intent to withdraw, portions of the below-listed tariff.

• General Exchange Tariff P.S.C. Mo. - No. 35

This Notice of Election and Withdrawal shall become effective May 1, 2012. With this Notice, the Company is withdrawing the rates, charges, terms and conditions in Sections 1 through 16, 18 through 27, 29, 30, 32, 33, 35, 36, 38 through 41 and 43 through 59. The Company will make available these rates, charges, terms and conditions on its website at <a href="https://www.att.com/servicepublications">www.att.com/servicepublications</a>. The following sections of the General Exchange Tariff will remain filed with the Commission.

Minor administrative changes have also been made to these sections. The tariff revisions are reflected on the attached tariff sheets, with issued and effective dates of March 30, 2012 and May 1, 2012, respectively.
