# ORDER DIRECTING NOTICE AND SETTING A DEADLINE FOR APPLICATIONS TO INTERVENE AND FOR STAFF TO FILE A RECOMMENDATION

Issue Date: February 2, 2023 Effective Date: February 2, 2023 On February 2, 2023, Vicinity Energy, Kansas City, Inc. (Vicinity) filed tariff sheets (Tracking No. JH-2023-0140) to change Vicinity's production adjustment cost clause (PACC) rates for steam service. The tariff sheets have a proposed effective date of April 1, 2023. The Commission will direct notice to be provided of Vicinity's PACC filing. The Commission will also direct the Staff of the Missouri Public Service Commission to file a recommendation regarding Vicinity's tariff sheets. A deadline will be set for any other party to file a response to the tariff sheets or Staff's recommendation.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all parties to Vicinity's last general rate case, File No. HR-2023-0198.

2. The Commission's Data Center shall provide a copy of this order to the County Commission for Jackson County, Missouri.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing Jackson County, Missouri, and to the media serving Jackson County, Missouri. 4. Any person wishing to intervene in this matter shall file an application to intervene no later than February 22, 2023. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission.

5. Staff shall file its recommendation regarding Vicinity's revised tariff sheets no later than March 6, 2023.

6. Any party wishing to comment on the tariff sheets or Staff's recommendation shall do so no later than March 13, 2023.

7. This order shall be effective when issued.
