APPLICATION FOR A CERTIFICATE OF SERVICE AUTHORITY AND COMPETITIVE CLASSIFICATION

Pursuant to the Order Approving Transfer of Assets and Granting a Waiver of 4 CSR 240.33.150 issued in Case No. XM-2003-0274 on May 29, 2003 (the "Order," attached hereto as **Exhibit A**), Matrix Telecom, Inc. d/b/a IE Com ("Matrix" or "Applicant"), by its undersigned counsel, and pursuant to Mo. Rev. Stat. § 392.440, and 4 CSR 240-2.060, hereby submits its application for a Certificate of Service Authority to operate as a reseller of intrastate interexchange telecommunications services in the State of Missouri. Additionally, pursuant to Mo. Rev. Stat. §§ 392.361 and 392.420, Matrix requests that it be classified as competitive, and requests that certain Commission rules and statutory provisions be waived pursuant to Mo. Rev. Stat. § 392.420. In support thereof, Matrix provides the following information, as well as its tariff.

I. QUALIFICATIONS

II. PROPOSED SERVICES

> 6. Matrix seeks authority to provide resold intrastate interexchange

telecommunications services to subscribers to and from all points in the state of Missouri.

- 2 **-**

Matrix proposes to provide resold interexchange services, including, but not limited to, direct-dial "1+" long-distance message telecommunications service ("MTS") and prepaid and postpaid calling card service to business and residential customers. MTS services are provided via Feature Group Access. Matrix's services are available on a full time basis, 24 hours a day, seven days a week.

- 7. Pursuant to the Order, Matrix is adopting, ratifying, and making its own, in every respect as if the same had been originally filed by it, all schedules, rules, notices, concurrences, schedule agreements, divisions, authorities or other instruments whatsoever filed with the Public Service Commission, State of Missouri, by International Exchange Communications, Inc. d/b/a IE COM in its P.S.C.MO. No. 1. Matrix is attaching the Title Sheet and Adoption Notice as **Exhibit D**. The Title Sheet and Adoption Notice have been provided separately to the Commission.
- 8. Matrix possesses managerial and technical expertise to provide competitive interexchange telecommunications services in Missouri. Matrix's officers and other members of its management team are well qualified to execute its business plan, having extensive managerial, financial, and technical telecommunications experience. A description of the qualifications of Matrix's management team is attached as **Exhibit E**.
- 9. Matrix has adequate financial resources to conducts its telecommunications operations as proposed in this Application. Confidential financial information pertaining to Matrix's financial resources has been filed pursuant to a Protective Order in Case No. XM-2003-027, filed as attachment E, filed pursuant to a Protective Order to the Joint Application of Matrix Telecom, Inc. and International Exchange Communications, Inc. for Approval of the Transfer of Certain Assets and Related Transactions and a Waiver of Applicable Anti-Slamming Regulations.

- 10. Matrix's toll-free number for customer inquiries is (800) 829-9866.
- 11. Matrix has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of this application.
 - 12. Matrix has no overdue annual report or assessment fees.

III. <u>CLASSIFICATION AS A COMPETITIVE TELECOMMUNICATIONS</u> <u>COMPANY AND WAIVER OF CERTAIN REGULATORY REQUIREMENTS</u>

13. Matrix also requests classification of its proposed telecommunications services as competitive, with accompanying reduced regulation, pursuant to Mo. Rev. Stat. §§ 392.361 and 392.420. Matrix respectfully requests that the Commission suspend, waive, or modify the application of the following statutory provisions and rules consistent with the Commission's treatment of other competitive interexchange carriers:

(a) Missouri Commission Rules

4 CSR 240.3.545(2)(C)	Posting of Rate Schedules.
4 CSR 240-10.020	Depreciation fund income.
4 CSR 240-30.040	Uniform system of accounts.

14. The above-referenced statutory provisions and rules have been waived with regard to other interexchange carriers in prior cases. These statutory provisions or rules are principally designed to apply to noncompetitive telecommunications carriers. It would be

inconsistent with the goal and purpose of Mo. Rev. Stat. § 392.530, to apply them to a competitive telecommunications carrier such as Matrix. No public utility will be affected by

granting the requested waivers.

15. Matrix, pursuant to Mo. Rev. Stat. § 386.570 will comply with all orders and

regulations of the commission applicable to providers of competitive interexchange

telecommunications services, except those that are specifically waived by the commission

pursuant to a request filed by Applicant.

16. Matrix submits that the public interest will be served by Commission approval of

this application because Matrix's proposed services will create and enhance competition and

expand customer service options consistent with the legislative goals set forth in the Federal

Telecommunications Act of 1996 and Mo. Rev. Stat. Chapter 392. Prompt approval of this

application will expand the availability of innovative, high quality, and reliable

telecommunications services within the State of Missouri.

WHEREFORE, Matrix Telecom, Inc. d/b/a IE Com requests that the Missouri Public

Service Commission grant the requested Certificate of Service Authority, to provide resold

interexchange telecommunications services in the State of Missouri, classify Applicant's proposed

services as competitive, and grant a waiver of the statutes and regulations referenced above.

ORDER APPROVING TRANSFER OF ASSETS, AND GRANTING A WAIVER OF 4 CSR 240-33.150

Syllabus: This order approves the transfer of assets and subscribers of International Exchange Communications, Inc., to Matrix Telecom, Inc., and grants a waiver of Commission rule 4 CSR 240-33,150.

On February 5, 2003, IECom and Matrix filed a joint application for approval of the transfer of assets and subscribers of IECom to Matrix and for a waiver of Commission rule 4 CSR 240-33.150. On March 6, 2003, the Applicants filed a supplement to their application.

Matrix was granted a certificate by the Commission on December 15, 1991, in Case No. TA-91-237. IECom was granted a certificate by the Commission on December 27, 1999, in Case No. TA-2000-196. On December 29, 2000, IECom and Matrix entered into a management services agreement under which Matrix has been providing telecommunications services to IECom's customers under IECom's supervision. The management services agreement also contained an asset purchase agreement.

On January 4, 2001, IECom filed a voluntary petition under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court, Northern District of California, San Francisco Division. The companies now come to the Commission for authority to transfer the assets of IECom to Matrix pursuant to Section 392.300, RSMo, and 4 CSR 240-2.060.

Applicants further request a waiver of 4 CSR 240-33.150, which requires customer authorization and verification of changes in telecommunications providers. Applicants state that among the assets being transferred is the right to use IECom's name, logos, etc., and it intends to continue service to IECom's customers under the same rates, terms, and conditions as IECom. The Applicants state that the transfer will allow IECom's customers to avoid a discontinuance of service that would otherwise occur if the transfer is not approved. The Applicants also state that the transfer will be transparent to the current customers of IECom.

The Applicants stated that the sale of assets will have no tax impact on any political subdivision in Missouri and that the companies have no pending or final judgments against them from any state or federal agency that involve customer service or rates. Applicants stated that they were current on Missouri assessments and fees and in filing annual reports.

The Commission's Staff filed its recommendation regarding the sale of assets on April 10, 2003. On April 21, 2003, Staff filed a supplemental response to its recommendation. Staff recommended that the approval of the proposed transactions not become effective until the following conditions have been met:

1) That Matrix Telecom, Inc. receive authorization from the Missouri Secretary of State to use the fictitious name Matrix Telecom, Inc. d/b/a

International Exchange Communications, Inc., and that Matrix file such authorization with the Commission; 2) That Matrix Telecom, Inc. apply for a certificate of service authority as Matrix Telecom, Inc. d/b/a International Exchange Communications, Inc. and receive such certificate from the Commission; and 3) That Matrix Telecom, Inc. d/b/a International Exchange Communications, Inc. adopt International Exchange Communications, Inc.'s tariff.

Staff also recommended that the Commission grant a waiver of the applicable subscribed authorization and verification requirement, 4 CSR 240-33.150, under the condition that the customers receive notice of the transactions. The rule requires, among other things, that no subscriber's selection of a provider of telecommunications service will be changed without that subscriber's authorization and without the carrier's confirmation of that authorization.

No response to Staff's recommendations was filed.

The standard for approval of a sale of assets is that the sale will not be detrimental to the public interest. The Commission has reviewed the application and Staff's recommendations and finds that the proposed sale of assets will have no adverse impact on the Missouri customers of IECom and Matrix. The Commission finds that the transaction is not detrimental to the public interest and should be approved. In addition, the Commission finds that the conditions recommended by Staff are appropriate. The Commission also determines that waiver of 4 CSR 240-33.150 is consistent with the purposes of Chapter 392, RSMo, and reasonable so long as the customers of the applicants receive the notice provided in the application. Therefore, the Commission will grant a waiver of 4 CSR 240-33.150.

IT IS THEREFORE ORDERED:

- That the joint application of International Exchange Communications, Inc., to
 Matrix Telecom, Inc., for approval of a sale of assets is granted.
- 2. That International Exchange Communications, Inc., and Matrix Telecom, Inc., are authorized to take any and all lawful actions necessary to carry out the proposed sale of assets presented to the Commission.
- 3. That before Matrix Telecom, Inc., may operate in the state of Missouri as Matrix Telecom, Inc., d/b/a International Exchange Communications, Inc., it must receive authorization from the Missouri Secretary of State to use the fictitious name Matrix Telecom, Inc., d/b/a International Exchange Communications, Inc., and that Matrix shall file a copy of that authorization with the Commission.
- 4. That before Matrix Telecom, Inc., may operate in the state of Missouri as Matrix Telecom, Inc., d/b/a International Exchange Communications, Inc., it must be granted a certificate of service authority as Matrix Telecom, Inc., d/b/a International Exchange Communications, Inc.
- 5. That before Matrix Telecom, Inc., may operate in the state of Missouri as Matrix Telecom, Inc., d/b/a International Exchange Communications, Inc., it shall adopt International Exchange Communications, Inc.'s tariff.
- 6. That a waiver of Commission rule 4 CSR 240-33.150, Verification of Orders for Changing Telecommunications Service Provider, is granted.
- 7. That Matrix Telecom, Inc. d/b/a International Exchange Communications, Inc., shall notify its customers that it has assumed the provision of the telecommunications

services in the next regular billing cycle of its customers after the transactions are complete.

- 8. That Matrix Telecom, Inc., shall file a report in this case stating the status of the transactions and conditions set out in the ordered paragraphs above no later than August 27, 2003, and continuing every 90 days until it has notified the Commission that all the conditions and transactions have been completed.
 - 9. That this order shall become effective on June 8, 2003.



Rick Nagel Executive Vice President, Sales & Marketing
