## ORDER FURTHER STAYING PROCEEDINGS

This case concerns Laclede Gas Company's application for authority to sell a section of natural gas pipeline to an affiliated company, Spire STL Pipeline, LLC. At Laclede's request, the Commission stayed these proceedings until May 1, 2017, to allow Spire STL Pipeline to decide whether it still wants to purchase the pipeline from Laclede.

On May 1, Laclede filed a status report explaining that Spire STL Pipeline has informed the Federal Energy Regulatory Commission (FERC) that it now prefers an alternative route for its proposed pipeline that will not require the purchase of a section of Laclede's pipeline. However, the plan that would require Spire STL Pipeline to purchase the pipeline from Laclede is still an option that could be approved by FERC.

Laclede asks that this case remain stayed until FERC makes a decision on Spire STL Pipeline's amended application. If FERC has not made that decision by December 1, 2017, Laclede will file another status report with the Commission.

The Commission finds that this case should be stayed pending a decision by the FERC.

**THE COMMISSION ORDERS THAT:**

1. Proceedings in this case are stayed until Laclede Gas Company dismisses its application, or until further order of the Commission.

2. If this application is not earlier dismissed, Laclede Gas Company shall file a status report no later than December 1, 2017.

3. This order shall be effective when issued.
