COMES NOW KCP&L Greater Missouri Operations Company (“GMO” or “Company”), pursuant to 4 CSR 240-20.100(10) and 4 CSR 240-2.060(4), and hereby requests a variance of 4 CSR 240-20.100(7) which requires that the RES Compliance Plan be filed by April 15, and requests that the Company be granted a six (6) week extension until May 28, 2013 to file its RES Compliance Plan. In support of this application, the Company states as follows:

2. The Company is currently in the process of preparing its 2013 Annual RES Compliance Report, and intends to file it by April 15, 2013. However, additional time is necessary to ensure that the RES Compliance Plan complies with Section 393.1030 RSMo Supp. 2009, the Commission's RES rules, and *State ex rel. Missouri Energy Development Association v. Public Service Commission*, 386 S.W.3d 165 (Mo. App. 2012).

OTHER INFORMATION

3. Pursuant to 4 CSR 240-2.060(1), the Company provides the following additional information. GMO is a Delaware corporation with its principal office and place of business at 1200 Main Street, Kansas City, Missouri 64105. GMO is primarily engaged in the business of providing electric and steam utility service in Missouri to the public in its certificated areas. GMO is an electrical corporation and public utility as defined in Section 386.020 (2000), as amended. A Certificate of Authority for a foreign corporation to do business in the State of Missouri, evidencing the Company's authority under law to conduct business in the State of Missouri was filed with the Commission in Case No. EU-2002-1053 and is incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G). GMO's fictitious name registration was filed in Case No. EN-2009-0015 and is incorporated herein by reference.

4. GMO holds Certificates of Convenience and Necessity from the Commission to transact business as an electric public utility in certain areas of the State of Missouri and is principally engaged in the generation, transmission, distribution and sale of electric power and energy. GMO has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer service or rates, which has occurred within three years of the date of this Application other than the following pending actions: *Ag Processing, Inc. a Cooperative v. KCP&L Greater Missouri Operations Company*, Case No. HC-2012-0259; *Earth Island Institute d/b/a Renew Missouri, et al. v. KCP&L Greater Missouri Operations Company*, Case No. EC-2013-0380. In addition, no annual report or assessment fees are overdue.
