## ORDER DIRECTING THE FILING OF A PROPOSED PROCEDURAL SCHEDULE OR STATUS REPORT

On December 15, 2022, the Staff of the Commission (Staff) filed its recommendation that certain disallowances be made to Spire Missouri, Inc. d/b/a Spire's (Spire West) 2020-2021 Actual Cost Adjustment balance. Spire West filed a response to the recommendation disputing Staff's recommended disallowances. Discussions are ongoing between Staff and Spire West.

Staff requests the Commission order a proposed procedural schedule or a status report by March 20, 2023. Therefore, the Commission will direct the parties to file a proposed procedural schedule or a status report.

### THE COMMISSION ORDERS THAT:

1. The parties shall file a joint proposed procedural schedule or a status report no later than March 20, 2023.
2. This order shall be effective when issued.
