# ORDER DIRECTING AN EXPEDITED STAFF TARIFF RECOMMENDATION AND SETTING TIME FOR TARIFF RESPONSES

On December 2, 2022, Spire Missouri, Inc. d/b/a Spire filed tariff sheets to comply with the Commission's November 30, 2022, order approving a stipulation and agreement resolving Spire's general rate case. Those tariff sheets bear an effective date of January 1, 2023, but Spire has requested those tariff sheets take effect on December 26, 2022. In consideration of the requested effective date of the tariff sheets, the Commission will direct its Staff to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other responses to the tariff sheets.

### THE COMMISSION ORDERS THAT:

- 1. Staff shall file a recommendation regarding the tariff sheets filed by Spire no later than December 8, 2022.
- 2. Any other responses to the tariff sheets shall be filed no later than December 8, 2022.
