- (B) Evidence of registration of the name change with the Missouri Secretary of State; and,

- (C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.
- 3. As explained in Staff's *Memorandum*, Staff reviewed the application and determined that Liberty has complied with these requirements.

WHEREFORE, Staff recommends that the Commission issue an order approving the following proposed tariff sheets to become effective on November 1, 2013, the requested effective date:

On July 2, 2012, Liberty Energy (Midstates) Corporation ("Liberty") filed for a name change to Liberty Energy (Midstates) Corporation d/b/a Liberty Utilities ("Liberty Utilities"). On July 23, 2012, the Missouri Public Service Commission ("Commission") issued an Order Recognizing Name Change and Approving Tariff Sheets to Liberty Energy (Midstates) Corporation d/b/a Liberty Utilities.
