**CONAGRA ENERGY SERVICES, INC., N/K/A CONAGRA TRADE GROUP,
INC. ANSWERS TO THE PUBLIC SERVICE COMMISSION'S DATA
INFORMATION REQUEST**

REQUEST NO. 1: Please provide a full statement of the type of business that
your company is engaged in.

RESPONSE: ConAgra Energy Services, Inc., n/k/a ConAgra Trade Group, Inc.
(ConAgra Trade Group”), is a wholly-owned subsidiary of ConAgra Foods, Inc.
ConAgra Foods, Inc. produces such products as shelf-stable, frozen and refrigerated
consumer products, which are processed and packaged for sales to retail, deli and
foodservice customers. ConAgra Trade Group is primarily responsible for procuring and
managing the supply of commodity inputs for the manufacture of these products. These
inputs include agricultural inputs and energy inputs.

REQUEST NO. 2: Please state whether your company provides “energy
services.” “Energy services” as used herein means: “the retail sale of electricity or natural

gas, propane or methane to customers or consumers and all associated services that are necessary for their delivery through a distribution system including but not limited to the generation, production, transmission, distribution, billing and metering of such services.” This definition is from Section 393.299(4) (RSMo Supp. 2003).

RESPONSE: ConAgra Trade Group does not provide “energy services” within the meaning of Section 393.299(4) (RSMo. Supp. 2003). ConAgra Trade Group is not engaged in the retail sale of natural gas in the State of Missouri. ConAgra Trade Group purchases natural gas only for use in ConAgra Food, Inc.’s processing facilities; not for resale, reuse or redistribution.


REQUEST NO. 3: Please state whether you are registered with the Missouri Secretary of State to do business in Missouri.

RESPONSE: ConAgra Trade Group is registered with the Missouri Secretary of State to do business in Missouri and as of July 17, 2002 was registered under the name “ConAgra Trade Group, Inc.”.

REQUEST NO. 4: If so, please state your specific registered name and registered agent.

RESPONSE: ConAgra Trade Group’s Missouri Tax Identification Number is 15949991. Its agent for service of process is Corporation Service Company, 221 Bolivar Street, Jefferson City, Missouri 65101.
