**ORDER DIRECTING STAFF TO REPLY**

On December 16, 2016, the Staff of the Commission filed a recommendation and memorandum indicating Staff has reviewed the 2014-2015 Actual Cost Adjustment (ACA) filing of Laclede Gas Company. Staff proposed no financial adjustments to Laclede's ACA balances, but offered non-financial recommendations regarding the company's policies. The Commission directed Laclede to respond to Staff's recommendations, and the company did so on January 30, 2017.

Before acting to resolve Laclede's actual cost adjustment filing, the Commission will direct Staff to indicate whether it is satisfied with Laclede's response and whether it is now appropriate for the Commission to establish the final balances for Laclede's 2014-2015 ACA.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Staff shall reply to Laclede Gas Company's Response to Staff Recommendation no later than February 16, 2017.

2. This order shall be effective when issued.
