ORDER APPROVING TARIFF

Issue Date: October 28, 2015

Effective Date: November 1, 2015

On October 15, 2015, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed tariff sheets proposed to become effective on November 1, 2015. The tariff sheets reflect changes in Ameren Missouri’s Purchased Gas Adjustment (“PGA”) as a result of estimated changes in the cost of natural gas and changes in the Actual Cost Adjustment (“ACA”). The changes in the PGA factors applicable to Ameren Missouri’s service areas will decrease the PGA factor.

The Commission’s staff (“Staff”) filed its recommendation on October 22, 2015. Staff recommends that the rates be approved on an interim basis, subject to refund, pending a final Commission decision in this action. Staff also asks to report on its review of documentation for the ACA by December 16, 2016. The Commission has reviewed the proposed tariff sheets and Staff’s recommendation.

The Commission independently finds and concludes that the proposed tariff sheets conform to Ameren Missouri’s Commission-approved PGA Clause. In addition, Ameren Missouri’s PGA Clause allows for PGA filings to take effect on ten days’ notice, which shows

good cause under Section 393.140(11), RSMo 2000, for the tariff to become effective on less than 30 days' notice. Therefore, the Commission will approve the tariff to become effective on November 1, 2015, on an interim basis as described above.

THE COMMISSION ORDERS THAT:

1. The proposed tariff filed assigned tracking no. JG-2015-0304 is approved to become effective on November 1, 2015, on an interim basis as described in the body of this order.

2. The specific tariff sheets approved are:

3. No later than December 16, 2016, the Commission's staff shall file a report on the documentation for the Actual Cost Adjustment.

4. This order shall be effective on November 1, 2015.
