The Commission will direct its Staff to file a recommendation regarding the tariff and will establish a time for any other party to file a recommendation if they choose to do so.

1. The Commission's Staff shall file a recommendation regarding the compliance tariff filed by Liberty Utilities (Tariff No. YG-2018-0165) no later than June 15, 2018.
2. Any other party wishing to file a recommendation regarding the compliance tariff filed by Liberty Utilities (Tariff No. YG-2018-0165) shall do so no later than June 15, 2018.

3. This order shall be effective when issued.
