**ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND
ESTABLISHING TIME FOR RESPONSE**

On November 3, 2017, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed a tariff that would make an adjustment to the winter Purchased Gas Adjustment (PGA) rate for its four service areas. Liberty Utilities is proposing to adjust the current cost of gas factor. The tariff has a proposed effective date of December 1, 2017. The Commission will direct the Staff of the Commission to file a recommendation on Liberty Utilities' tariff by November 14, 2017. The Commission will also establish a deadline for any other entity to file a response to the tariff or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Liberty Utilities' tariff no later than November 14, 2017.
2. Any other entity wishing to comment on the tariff or Staff's recommendation shall do so no later than November 17, 2017.

3. This order shall be effective when issued.
