**ORDER REVISING DEADLINES**

On October 26, 2017, the Commission issued its *Order Directing Expedited Response*, which set an October 31, 2017 deadline for the Commission's Staff to submit a recommendation on Summit Natural Gas of Missouri, Inc.'s tariff sheets to change the company's Purchased Gas Adjustment clause. The order also set a November 3, 2017 deadline for entities to submit a response to either the tariff sheets or Staff's recommendation.

However, since the tariff sheets bear an effective date of November 8, 2017, the Commission must allow time for a review of Staff's recommendations, any responses, and the issuance of a Commission order before the effective date. Therefore, the Commission will revise the deadlines in its *Order Directing Expedited Response*.

**THE COMMISSION ORDERS THAT:**

1. No later than October 30, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff sheets filed by Summit Natural Gas of Missouri, Inc.
2. Any other entity wanting to comment on the tariff sheets or Staff's recommendation shall do so no later than October 31, 2017.

3. This order shall be effective when issued.
