## ORDER MODIFYING PROCEDURAL SCHEDULE

Issue Date: June 18, 2013 Effective Date: June 18, 2013

On June 17, 2013, Southern Union Company d/b/a Missouri Gas Energy, the Laclede Group, Inc., Laclede Gas Company, the Staff of the Commission, and the Office of the Public Counsel filed a joint motion asking the Commission to modify the procedural schedule for this case. The motion explains the parties are negotiating toward a settlement and wish to concentrate on those negotiations rather than prepare testimony. The moving parties ask the Commission to modify the procedural schedule to extend the date for filing rebuttal testimony from June 24 to June 28. They also ask that the filing date for surrebuttal testimony be extended from July 5 to July 8. The motion represents that the parties that did not join in the motion have been consulted about the proposed modifications and that none has expressed opposition to the modification of the procedural schedule.

The Commission finds that the moving parties have demonstrated good cause to modify the procedural schedule and the Commission will modify the schedule as they request.
