**ORDER DIRECTING ADDITIONAL STATUS REPORT**

This case concerns Spire Missouri, Inc.'s application for authority to sell a section of natural gas pipeline to an affiliated company, Spire STL Pipeline, LLC. At Spire's request, the Commission stayed these proceedings indefinitely to allow Spire STL Pipeline to decide whether it still wants to purchase the pipeline from Spire based on an anticipated decision by the Federal Energy Regulatory Commission (FERC) regarding an alternative route for its proposed pipeline that will not require the purchase of a section of Spire's pipeline.

Spire filed a status report on February 28, 2018, indicating the FERC has not yet made a decision regarding Spire STL Pipeline's application. Spire indicates its intent to file an additional status report by August 1, 2018.

The Commission will direct Spire to file the promised status report.

**THE COMMISSION ORDERS THAT:**

1. If this application is not earlier dismissed, Spire Missouri, Inc. shall file a status report no later than August 1, 2018.

2. This order shall be effective when issued.
