MOTION FOR EXPEDITED TREATMENT

COMES NOW KCP&L Greater Missouri Operations Company ("GMO" or "Company"), pursuant to 4 CSR 240-2.080(14) and hereby requests expedited treatment and approval by the Missouri Public Service Commission ("Commission") of the Company's Net Metering Interconnection tariff sheets and Solar Photovoltaic Rebate Program tariff sheets in above-captioned matter.

1. On October 25, 2013, GMO, Staff of the Missouri Public Service Commission, Office of the Public Counsel, Brightergy, LLC, Missouri Division of Energy and Missouri Solar Energy Industries Association (collectively, the "Signatories") entered into and filed a Stipulation and Agreement ("Stipulation"). Attachment A to the Stipulation contained specimen tariff sheets which were approved by the Signatories.

2. As outlined on page two of the Stipulation, "GMO will file a request for expedited approval of those tariffs and the Signatories agree that they will not oppose that request." Therefore, pursuant to the Stipulation and 4 CSR 240-2.080(14), the Company hereby requests expedited treatment and approval of its new tariff sheets:

PSC Mo. No. 1 Revised Sheet No. 110 through 118, 119.2, 119.4, 119.6 and 119.7
PSC Mo. No. 1 Original Sheet No. 119.8 and 119.9
PSC Mo. No. 1 Revised Sheet No. R-62.20
PSC Mo. No. 1 Original Sheet No. R-62.21

3. On October 30, 2013, the Commission issued its Order Approving Stipulation and Agreement. Ordered paragraph 3 states:

No later than November 13, 2013, KCP&L Greater Missouri Operations Company shall file with the Commission a notice of withdrawal of the Tariff File No. JE-2014-0059 and file new tariff sheets that reflect the tariff sheets attached to the *Stipulation and Agreement*.

4. At the time of this filing, the Company has withdrawn Tariff File No. JE-2014-0059 and submit with this Motion for Expedited Treatment new tariff sheets. The new tariff sheets filed contemporaneously with this motion bear a 30 day effective date. The Company requests that the new tariff sheets become effective in 10 days (i.e. November 18, 2013) since all of the parties have already reviewed and approved the tariff sheets. There will be no harm to the general public if this motion is granted. This motion was filed as soon as it could have after the tariff sheets were filed.

WHEREFORE, for the foregoing reasons, KCP&L Greater Missouri Operations Company respectfully requests that the Commission grant it expedited treatment and approval of its new tariff sheets as outlined in paragraph 2 above and filed herewith.
