**NOTICE REGARDING REQUEST TO TAKE OFFICIAL NOTICE OF
FEDERAL D.C. CIRCUIT DECISION**

Issue Date: September 1, 2021

On August 5, 2021, the Environmental Defense Fund, Midwest Energy Consumers Group, and Consumers Council of Missouri (collectively “Movants”) filed a joint motion asking that the Commission take official notice of the United States Court of Appeals for the District of Columbia Circuit’s June 22, 2021 decision in the case captioned: *Environmental Defense Fund v. Federal Energy Regulatory Commission*. Movants’ motion also responds to Spire Missouri, Inc. d/b/a Spire’s presentation regarding the Spire STL Pipeline given at the Commission’s July 14, 2021 agenda meeting.

The Commission is aware of the June 22, 2021 decision and is continuing to closely monitor the ongoing federal issues concerning the Spire STL Pipeline.¹

On January 6, 2021, the Commission issued an order informing the parties that it would not establish a procedural schedule until after the Staff of the Commission files its report concerning Spire's Actual Cost Adjustment filing. That report is due December 15, 2021. Accordingly, the Commission is not taking evidence for the record at this time, but Movants will have an opportunity to renew their request before the Commission issues a decision on Spire's Actual Cost Adjustment filing.
