ORDER GRANTING AN EXTENSION OF TIME TO RESPOND TO STAFF'S ACA RECOMMENDATION

Issue Date: July 12, 2022

Effective Date: July 12, 2022

On May 27, 2022, the Staff of the Commission (Staff) filed its Actual Cost Adjustment (ACA) review, recommendation, and report in File No. GR-2021-0127. The Commission set a deadline of July 11, 2022, for Spire Missouri, Inc. d/b/a Spire to respond to Staff's recommendation, and a deadline of July 18, 2022, for any other responses to Staff's recommendation or Spire's response.

On July 8, 2022, Environmental Defense Fund (EDF), the Office of the Public Counsel (OPC), and Consumers Council of Missouri filed a request to extend the time for responses to Staff's recommendation or Spire's response. They ask for additional time to respond due to the complexity of this matter. The motion represents that Spire, Staff, and Midwest Energy Consumers Group do not object.

The Commission will grant the motion for an extension.

¹ The Commission issued its Order Establishing Ending ACA Balance on February 2, 2022, in GR-2021-0218. No further filings are necessary in that matter. Parties addressing the prudence of Spire Missouri East's ACA should file pleadings only in GR-2021-0127.

THE COMMISSION ORDERS THAT:

1. EDF, OPC, and Consumers Council of Missouri's motion for an extension of time is granted. Any responses to Staff's recommendation and Spire's response are due no later than August 1, 2022.
2. This order is effective when issued.
