# OPC'S LOCAL PUBLIC HEARINGS AND NOTICE RECOMMENDATIONS

**COMES NOW** the Office of Public Counsel ("OPC") and, in response to the Commission's November 10, 2021, order directed the parties to, "[n]o later than November 19, 2021, . . . file a pleading recommending the number, locations, dates and times for local public hearing," recommends to the Commission that it hold four local public hearings in this case at the following locations, dates, and times that follow below.

Before making specific recommendations, OPC offers that due to the ongoing COVID-19 pandemic, the Commission should conduct its local public hearings with appropriate protocols in place to protect all present from exposure to COVID-19, ideally while giving members of the public the opportunity to appear in person to testify and offer any writings or other evidence, and also provide the option for members of the public to participate virtually.<sup>1</sup>

(1) Due to the geographic scope of Liberty's service area and that this is the first rate case for Liberty for over a decade and the first since Algonquin Power and Utilities Corp. acquired it, the Commission should hold four local public hearings—one each at **Sedalia**, **Maryville**, **Chillicothe**, and **Nevada**, Missouri. To maximize public participation, but also balance the risk of exposure to COVID-19, in order of declining preference, the Commission should conduct those hearings as follows:

At each

hearing members of the public have the opportunity to appear in person to testify and offer any writings or other evidence, or to appear virtually, at their option;

- (2) At specified hearings members of the public have the opportunity to appear in person to testify and to offer any writings or other evidence, and at a different specified hearing they only may appear virtually; and
- (3) At all local public hearings members of the public only may appear virtually.

Based on Liberty's last general recase (Case No. GR-2009-0434), but without confirming their availabilities on the dates and at the times suggested, OPC recommends the local public hearing schedule that follows:

Should the Commission decide not to hold local public hearings where members of the public have the opportunity to appear in person to testify and offer any writings or other evidence, OPC does not oppose Staff and Liberty's recommendation that the Commission hold two virtual local public hearings, one at 6:00 P.M., Thursday, February 17, 2022, and one at noon, Tuesday,

February 22, 2022.

OPC also recommends that the Commission order Liberty to mail to its customers a local public hearing notice similar in form to the following. It is OPC's understanding that for Liberty to distribute such a customer notice to all of its customers as a bill insert, it would need to know the final form of the notice on or about the end of this calendar year.

#### NOTICE OF LOCAL PUBLIC HEARINGS ON LIBERTY'S GAS RATES

On August 23, 2021, The Empire District Gas Company d/b/a. Liberty filed a general rate request with the Missouri Public Service Commission ("Commission"). Liberty is seeking in this proceeding to increase its annual gross revenues by approximately \$1.36 million, or approximately 4.16%, or 6.64% excluding gas revenues. As part of this proceeding, Liberty is proposing to increase its fixed residential customer charge from \$16.50 per month to \$18.10 per month. For a residential customer using 54 CCF of natural gas a month, Liberty's proposed increase is approximately \$2.71 each month, or 9.9% percent. Liberty estimates that the proposed rate increase will have the following annual bill impacts:

Residential	10.1% (600 CCF/year)
SGS	1.8% ((1,000 CCF/year)
SCSM	10.4% (7,000 CCF/year)
SCSL	-23.2% (10,000 CCF/year)
LGS	6.4% (100,000 CCF/year)

#### LOCAL PUBLIC HEARINGS

Due to the ongoing COVID-19 pandemic, for public safety, the Commission will hold in-person local public hearings where social distancing and mandatory face masks will be observed.
