On June 23, 2022, the Missouri Public Service Commission issued a *Report and Order* effective July 3, 2022, regarding The Empire District Gas Company's request for a rate increase. On July 1, 2022, The Missouri School Boards' Association filed a timely application for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

The Commission will deny the application for rehearing.

1. The Missouri School Boards' Association's Application for Rehearing or Reconsideration is denied.
