ORDER MODIFYING DATA REQUEST RESPONSE TIMES

Issue Date: August 22, 2022 Effective Date: August 22, 2022

On December 2, 2021, the Commission approved Regular Purchased Gas Adjustment (PGA) tariffs of Summit Natural Gas of Missouri, Inc. (SNGMO) and directed the Staff of the Commission (Staff) to file the results of its Actual Cost Adjustment (ACA) review no later than December 15, 2022. The Commission issued an order on December 8, 2021, setting a procedural schedule regarding SNGMO's PGA carrying costs for financing the unrecovered gas costs associated with Winter Storm Uri. At the request of the parties, the procedural schedule included shortening the response times for data requests to less than those provided in Commission Rule 20 CSR 4240-2.090.

On July 22, 2022, the parties filed a *Unanimous Stipulation and Agreement* that purports to settle the carrying costs issue.

SNGMO filed a *Motion to Modify Data Request Response Times* on August 17, 2022. As the December 8th procedural schedule pertained only to the carrying costs issue, there is no procedural schedule in place regarding the ACA review by Staff. Thus, SNGMO – without objection from Staff or the Office of Public Counsel – requests an order from the Commission setting the time period for responding to data requests consistent with Commission Rule 20 CSR 4240-2.090.

The Commission will grant the motion.

THE COMMISSION ORDERS THAT:

1. Data requests related to the ACA review shall be answered by the recipient within 20 days of the request.

2. If the recipient of a data request related to the ACA review objects to the data request or is unable to answer the request within 20 days of the request, the recipient of the data request shall serve all objections or reasons for its inability to answer in writing upon the requesting party within 10 days after receipt of the data request.

3. This order shall be effective when issued.
