## ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On February 7, 2023, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment for its Kirksville service area. The tariff sheets bear an effective date of February 22, 2023.

In consideration of the effective date of the tariff sheets and the need to act at an agenda meeting before the tariff sheets take effect, the Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than February 14, 2023, Staff shall file a recommendation with regard to Tariff File No. YG-2023-0148.
2. Any other entity wanting to comment on the tariff sheets or respond to Staff's recommendation shall do so no later than February 15, 2023.
3. This order shall be effective when issued.
