2 JUDGE STEARLEY: Good morning. This
3 morning is October 10th, 2007, and we're here for
4 conferences in two matters that we've consolidated this
5 morning, if my understanding is correct; the case that I'm
6 presiding over in the matter of the general rate increase
7 for natural gas service provided by Missouri Gas Utility,
8 Incorporated, which is Case No. GR-2008-0060, and Judge
9 Dippell's case in the matter of Missouri Gas Utility,
10 Incorporated's purchased gas adjustment factors to be
11 audited in its 2005-2006 actual cost adjustment, Case No.
12 GR-2007-0178.

13 My name is Harold Stearley, and I'm the
14 presiding officer for this conference. Our court reporter
15 this morning is Kellene Feddersen. And we'll begin by
16 taking entries of appearance, starting with Missouri Gas
17 Utility.

18 MR. COOPER: Dean L. Cooper from the law
19 firm of Brydon, Swearngen & England, P.C., P.O. Box 456,

21 Missouri Gas Utility, Inc.

7 JUDGE STEARLEY: Thank you, Mr. Poston.
8 Are there any other -- any preliminary matters we need to
9 take up at this time? Anything pending?

10 (No response.)

11 JUDGE STEARLEY: All right. Well, I have
12 an order for procedural schedule in the rate case to be
13 due a week from today. It's also my understanding there's
14 no disagreement on the test year for the rate case.

15 MR. COOPER: The test year, yes.

16 JUDGE STEARLEY: So when the order comes
17 out adopting procedural schedule, I'm sure the Commission
18 will go ahead and approve that as well.

19 If there's no other matters we need to take
20 up --

21 MR. COOPER: Judge, I think that we
22 probably are -- I don't know that there's going to be a
23 disagreement, but I think that in terms of update or
24 true-up, that's one of the things we were going to discuss
25 today and make sure that everybody was on the same page

1 with that side of things.

2 JUDGE STEARLEY: All right. When you file
3 the procedural schedule, you can perhaps give me a status
4 report on that.

5 Well, if there's no other matters we need
6 to take up in the on-the-record portion of this, we will
7 go off the record and I'll leave you-all to your
8 deliberations. Thank you all.

9 WHEREUPON, the recorded portion of the
10 prehearing conference was concluded.
