APPLICATION FOR DESIGNATION AS ELIGIBLE CARRIER PURSUANT TO § 254 OF THE TELECOMMUNICATIONS ACT OF 1996

Comes now Green Hills Area Cellular Telephone, Inc. d/b/a Green Hills

Telecommunications Services ("GHTS" or "Applicant") and pursuant to § 254 of the

Telecommunications Act of 1996 ("the Act"), as well as the Federal Communications

Commission ("FCC") regulations found at 47 CFR 54.201, et seq, issued with the May 7,

1997 Report and Order of the FCC in FCC Docket No. 96-45, and hereby requests that the

Missouri Public Service Commission ("Commission") designate it as a telecommunications

carrier eligible under the provisions of 47 CFR 54.201(d) to receive federal universal service support.

In support of its Application, Applicant states as follows:

1. GHTS is a competitive local exchange company ("CLEC") certified by the Commission to provide basic local telecommunications service in the State of Missouri in Case No. TA-98-380. GHTS's street address and principal place of business is 7926 NE State Rt. M, Breckenridge, MO 64625-0227. GHTS's telephone number is (660) 644-5411, and it can be reached by facsimile at (660) 644-5464. Green Hills Area Cellular Telephone, Inc. is a Missouri corporation, and a copy of a Certificate of Good Standing from the Missouri

Secretary of State is marked <u>Appendix A</u> and attached hereto. A copy of GHTS's registration of fictitious name is marked <u>Appendix B</u> and attached hereto. GHTS's Interconnection Agreement with Sprint Missouri, Inc. d/b/a Sprint ("Sprint") was approved by this Commission in Case No. TO-99-75. Pursuant to tariffs approved by the Commission, GHTS provides basic local telecommunications service through the use of its own facilities in one Missouri exchange, Norborne.

3. Section 214(e)(1) of the Act states that a carrier may be designated as an eligible telecommunications carrier and therefore receive universal service support so long as the

carrier, throughout its service area: (1) offers the services that are supported by federal universal service support mechanisms under section 254(c) of the Act; (2) offers such services using its own facilities or a combination of its own facilities and resale of another carrier's services, including the services offered by another eligible telecommunications carrier; and (3) advertises the availability of and charges for such services using media of general distribution. Title 47 of the Code of Federal Regulations § 54.201(b) states that the Commission shall, on its own motion or upon request, designate a common carrier an "eligible telecommunications carrier" so long as the carrier meets the requirements of 47 CFR 54.201(d). Title 47 CFR § 54.201(c) further states that a state commission shall designate more than one common carrier as an eligible telecommunications carrier for a service area designated by the state commission so long as the additional requesting carrier meets the requirements of § 54.201(d).

- 4. GHTS, through its own facilities, offers all of the services supported by federal universal service support under § 254(c) of the Act. Specifically, GHTS offers the following services:
 - (1) Voice grade access to the public switched network;
 - (2) Local usage;
 - (3) Dual tone multi-frequency signaling or its functional equivalent;
 - (4) Single-party service or its functional equivalent;
 - (5) Access to emergency services;
 - (6) Access to operator services;
 - (7) Access to interexchange service;
 - (8) Access to directory assistance; and

- (9) Toll limitation for qualifying low-income consumers.¹
- 5. Applicant advertises the availability of and charges for such services using media of general distribution within its service area. An Affidavit of Publication showing proof of such advertising is attached as Appendix C.
- 6. Applicant acknowledges that 47 CFR 54.405 requires all eligible telecommunications carriers to make Lifeline services (as defined in 47 CFR 54.401) available to qualifying low-income consumers. Lifeline services are available to qualifying low-income consumers in its service area.
- 7. Applicant does not have any pending action, or final unsatisfied judgment or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application.
 - 8. Applicant does not have any annual reports or assessment fees that are overdue.

WHEREFORE, on the basis of the foregoing, Applicant respectfully requests that the Commission designate it as a telecommunications carrier eligible under the provisions of 47 CFR 54.201(d) to receive federal universal service support and for such other orders as are deemed necessary or convenient in this matter.

¹On December 30, 1997, the FCC changed its definition of toll-limitation services in its Fourth Order on Reconsideration of the Universal Service Report and Order, CC Docket Nos. 96-45 et al. The FCC stated, "we define toll-limitation services as either toll blocking or toll control and require telecommunications carriers to offer only one, and not necessarily both, of those services at this time in order to be designated as eligible telecommunications carriers." Id. at 2103. MTCC currently offers toll blocking service to qualifying customers.




