- On December 1, 2014, Grady with a mailing address of 1960 Dry Hollow Road,
 Saddlebrooke, Missouri 65630, filed a complaint against MAWC (the "Complaint").
 - 2. Any allegation not specifically admitted herein by MAWC is denied.
- 3. In response to the allegations of the Complaint, MAWC states that MAWC's first record of contact from Mr. Grady regarding the rate charged for sewer service was in September, 2014.
- 4. MAWC's rate charged to Mr. Grady for sewer service consists of a meter charge of \$40.97 and a usage charge of \$24.97.
- 5. The usage charge of \$24.97 is based upon the winter quarter average of 4,140 gallons which is the average usage for Saddlebrooke customers.
- 6. MAWC reviewed the rate being charge Mr. Grady per Tariff sheet P.S.C. MO. No. 16 Sheet 1 b, attached hereto as Exhibit A, and approved by the Missouri Public Service Commission on July 19, 2012 with an effective date of August 10, 2012.
 - 7. The charge for Mr. Grady's sewer service is correct.
 - 8. MAWC denies that Mr. Grady is being overcharged for his sewer service.
