## **REQUESTS FOR WAIVER**

- 1. In Case No. EA-2016-0358, the Missouri Public Service Commission ("Commission") issued a Certificate of Convenience and Necessity to Grain Belt Express Clean Line LLC to construct a high voltage direct current transmission line and associated facilities (the "Project") in the State of Missouri. In Case No. EM-2019-0150, the Commission approved an acquisition by which Invenergy Transmission LLC acquired Grain Belt Express Cline Line LLC from Clean Line Energy Partners LLC.
- 2. Grain Belt Express Clean Line LLC is now changing its name to Grain Belt Express LLC. Concurrently with this Request for Waivers, Grain Belt Express LLC is filing a letter pursuant to 20 CSR 4240-2.060(5), along with the items required under subsections (A) and (B) of 20 CSR 4240-2.060(5). Grain Belt Express LLC is not rate regulated by the Commission, so the name change does not impact any tariffs on file with the Commission. Accordingly, good cause exists for waiver of subsection (C) of 20 CSR 4240-2.060(5).
- 3. Further, Grain Belt Express LLC requests waiver of the 60-day notice requirement under 20 CSR 4240-4.017(1). There are no substantive issues to be determined by the Commission in this case and any delay in approving the name change would cause harm to the company and the public by extending the period of time that the company must operate under a name that is not reflective of its current ownership. Accordingly, good cause exists, pursuant to 20 CSR 4240-4.017(1)(D), to grant a waiver of 20 CSR 4240-4.017(1).

4. Wherefore, Grain Belt Express LLC respectfully requests that the Commission waive the tariff filing requirements of 20 CSR 4240-2.060(5)(C), waive the 60-day notice requirement of 20 CSR 4240-4.017(1), and approve the change in name of Grain Belt Express Clean Line LLC to Grain Belt Express LLC.
